//OFFICE MEMORANDUM//

Certain numbers posts of Preventive Officers may be required to be filled up in the Office of Development Commissioner, Kandla Special Economic Zone, Gujarat by way of appointment on deputation basis in the year 2017 – 18. The Pay scale of Preventive Officer is ₹ 9300-34800+4600(pre-revised) and according to recruitment rules, the posts are required to be filled in by deputation from the officers of Customs and Central Excise department holding analogous posts on regular basis & possessing two year experience in Customs or Central Excise procedural work. Maximum age limit for appointment by deputation shall not be exceeding 56 years as on the closing date of the receipt of applications.

The terms & conditions of deputation of Preventive Officer will be regulated in accordance with the instructions contained in Department of Personnel and Training O.M. No. 6/8/2009-Estt. (Pay-II) dated 17-06-2010 as amended from time to time, to draw pay of the post held by them in the parent department plus deputation allowance in accordance with and subject to the conditions laid down in the Ministry of Personnel, Public Grievances and Pensions, Department of Personnel & Training O.M. No. 2/8/97-ESTT (Pay-II) dated 11-03-1998 & No. 2/22/B/Estt/Pay/11 dated 03-09-2008 as modified from time to time and such other general or special orders issued by the Ministry of Finance. Tenure of deputation normally is three (03) years as per DOPT's guidelines.

The officers selected will be entitled to transfer T.A. and joining time in accordance with the Rules of the Government of India in force.

Names of officers who have worked in this Zone or in any SEZ, earlier (whether on deputation or on encadred post), and if three year cooling off period is not over, he may not be recommended, also officers with Vigilance clearance and clean reputation may only be recommended.

It is requested that the names of eligible and willing officers may be recommended in the prescribed proforma (Annexure I enclosed) along with 1) ACR grading for last five years duly attested by the competent authority, 2) Vigilance clearance certificate, 3) Integrity certificate, 4) Details of penalty, if any, imposed during last 10 years and any proceedings pending/contemplated against the officer. In absence of these requirements application will not be entertained. The last date of receipt of application of suitable officers through proper channel is 45 days from the date of issue of this office Memorandum. Applications received after the due date will not be considered. Advance copy of application will not be entertained.
