A) Fresh Proposal:-


6-A-01) Proposal of M/s. Entigrity Solutions LLP, Ahmedabad, for setting-up a new unit in Calica - IT/ITES - SEZ, Ognaj.

Shri Valay Parikh, Designated Partner, of applicant company M/s. Entigrity Solutions LLP, appeared before the Approval Committee for personal interview. He explained the proposal for setting-up of new IT/ITES service unit in Calica – IT/ITES-SEZ, Ognaj, Ahmedabad for export of services (online marketing).

A brief detail of the proposal is as under:-

- The FOB value for said project, for 5 (Five) years period is projected as Rs. 308.46 lakhs with no foreign exchange outgo, resulting in NFE of Rs. 308.46 lakhs (100%).
- Projected employment generation shall be 11 persons (10 men; & 1 woman); and Investment of Rs. 10.00 lakhs.
- The Developer, Calica Construction & Impex Pvt. Ltd., vide letter dated 11-11-2018 has earmarked & confirmed the required space in the incubation centre of SEZ for the proposed project. However, the Approval Committee noted that the premises earmarked for the above applicant is currently held by another M/s. Gameanax Labs LLP, which is under the process of exit. The premises may be allotted to the new applicant only after the due procedure for exit is completed.

The Approval Committee after due diligence and deliberation approved the project, subject to standard terms and conditions of the SEZ Rules, 2006.
