NOTICE INVITING 'EXPRESSION OF INTEREST'

Sub:- Notice inviting Expression of Interest (EOI) of Legal Firm/Advocates practicing in Gujarat preferably in Gandhidham having at least 5 years experience in the matters relating to Land issues, DRT, BIFR, AAIFR, Labour related matters, Foreign Trade Policy and SEZ Act/Rules, etc. reg.

Kandla SEZ Authority invites 'Expression of Interest' from experienced legal firms/Advocates having at least 5 years experience preferably on the above mentioned fields. The EOI should reach to this office on or before 30th April, 2018 upto 3.00 P.M.

document has been prescribed for submitting EOI. Interested Legal Firm/Advocates fulfilling the above requirements may submit their EOI on their letter head along with their profile, details of empanelment in other similar organizations, if any, alongwith copy of registration and details of advocates working in the firm with their expertise and experience. Following conditions may be kept in mind while submitting the EOI:-

- 1. The firm shall provide necessary legal service of all nature in consonance with the functions of Kandla SEZ, a Central Government organization.
- 2. The services to be performed shall comprise of legal opinion and advice to be rendered to the Authority, preparing Affidavits and presenting of Cases before various courts across the country, except different Benches of Hon'ble CAT, Hon'ble High Courts and the Hon'ble Supreme Court.
- 3. The Legal Firm/Advocate shall go through the files of the Authority involving legal issues and shall ensure saving of interest of the Authority.

- 4. The Legal Firm/Advocate shall be entitled for drafting & appearance charges, as fixed by Ministry of Law and Justice from time to time on case to case basis as per O.M. No.26(1)/2014-Judl. Dated 1st October, 2015 as amended from time to time.
- 5. Local & outstation travel expenses and Hotel accommodation will be as applicable to a Government Servant drawing Salary at Level-11.
- 6. For cases in High Court, Supreme Court and CAT, they will provide legal advisory services within the retainer-ship for which no fee will be payable separately, if required by the Authority.
- 7. The firm/advocate shall hold all information concerning the function of this organization in confidence and shall not disclose without prior consent of the CEO of the Authority/DC.
- 8. The firm/advocate shall visit the SEZ office twice in a week compulsorily for perusal of files, preparing legal opinion, counter affidavits, suits, etc. and also for appraising the Authority about the on-going cases, for which the Authority shall pay monthly retainer ship of Rs.30,000/-.
- 9. The engagement shall be for a period of one year which may be extended upto two times each time for a period of one year with 7% increase in retainer-ship amount. This will require approval of DC, Kandla SEZ & Chairman, Kandla SEZ Authority.
- 10. The contract may be terminated by either side giving one month's notice or immediately by paying an amount of Rs.30,000/-.

- 12. On any matter of dispute, decision of Kandla SEZ Authority (DC, Kandla SEZ) shall be final.
