The committee found that they have not done any survey of buyers for his trading products and found that the project proposal is flimsy and hence rejected.

85.2: MONITORING OF ANNUAL PERFORMANCE REPORT OF UNITRADE WORLD

The Annual performance of M/s. Unitrade World, KASEZ, for the Financial Year 2009-10 to 2014-15, was placed before the UAC. The Committee observed that APR's submitted by the unit for the second five years block period i.e. from 2009-10 to 2014-15 are "NIL". Thus the unit has not achieved positive NFE and accordingly they have contravened the provisions of Rule 53 of the SEZ Rules, 2006 and conditions as mentioned in their Letter of Approval renewed from time to time.

The Committee has directed to the D.C. office to initiate action under the said unit under the F.T (D&R) Act 1992 for non achievement of positive NFE for the year 2009-10 to 2014-15.
