57.1 Review/confirmation of the minutes of last meeting of the Approval Committee:

Minutes of the last meeting of the Approval Committee were confirmed.

57.2 New proposals:

57.2.1 Application for setting up of a unit in KASEZ namely M/s. Ashok and Company-Pan Bahar Ltd., Kanpur.

The proposal is to set up a unit for manufacturing activity of Pan Masala (ITC HS 21069020) and Pan Masala containing Tobacco (ITC HS 24039990). Promoters came for discussions and explained following:-

- > Their existing manufacturing activities are from Noida and they are exporting to Middle East.
- > They have already established export market, which do not wanted to loose.
- > There shall be no DTA sale, as there is already ban on tobacco products in India.
- Project cost is Rs.5.00 crores, which will be met from un-secured loan and past internal accruals.
- > Require a unit in SDF in Ground Floor.
- Employment 25 persons.
- > FOB value of Export projected for 5 year period is mentioned as Rs.23100 lakhs with NFE of Rs.23100 lakhs.

It was informed to the applicant that they will be given SDF unit, and the same was agreed by them. After deliberations, Approval Committee approved the proposal subject to standard terms and conditions and allotment of SDF. No DTA sale shall be permitted.

57.3 Broad Banding request in the existing LoA:

57.3.1 M/s. Medicare Industries, KASEZ.

M/s. Medicare Industries is an existing unit in KASEZ for manufacture of medical equipments, medical kits, cold chain equipment, etc.The present proposal is to broadband their LoA by adding "plastic containers" for manufacturing purpose.

FOB value of exports for 5 year period is mentioned as Rs.1049 lakhs with a NFE of Rs.162.52 lakhs. After deliberations, the Approval Committee approved their request for broad banding of their LOA for manufacture of "plastic containers". No additional premises will be allotted.
