Kandla SEZ Authority, Government of India, Ministry of Commerce & Industry, Kandla Special Economic Zone is engaged in development of Kandla Special Economic Zone, invites tenders for outsourcing of services of ten (10) Gunmen and 33 (33) Security Guards.

Licensed/Authorised Security Service Providers with minimum 3 years' experience in outsourcing of services of security services may apply in the prescribed format. Prescribed format and terms and conditions of the tender are available on website [www.kasez.com](http://www.kasez.com).

Sub:- Terms and conditions for Supply Services of 10 (ten) Gunmen and thirty three (33) Security Guards for 8 hours duty inclusive of all applicable taxes i.e. service tax, service charges, etc. Out of 33 security Guards, 6 (six) personnel should have valid heavy driving licence.

1. Quotations are invited in sealed envelope from Licenced/Authorized Security Service Providers marked "Quotation" against enquiry No.KASEZ/EM/III/171/2012 dated 01/08/2012 for supply of Services of 10 (ten) Gunmen and 33 (thirty three) Security Guards, out of which six persons should have valid heavy driving licence.
2. The service provider should have minimum 3 years' experience. Personnel deployed also should have sufficient experience.
3. They will be deployed mainly during night shift (10.00 p.m. to 06.00 a.m) at Kandla Special Economic Zone and if need arises during 1<sup>st</sup> (0600-1400 hrs) and 2<sup>nd</sup> shift (1400-2200 hrs) as required by the Security Officer, KASEZ. A Guard has to be deployed for 8 hours duty only.
4. Quotations should reach this office on or before 1200 hours on 24<sup>th</sup> August, 2012. Quotations received thereafter will not be considered.
5. Quotations should not be written with pencil. Such quotations will be rejected. Each page of quotation should be signed by the authorized signatory.
6. Quotations will be opened on 24/08/2012 at 1600 hrs. at Kandla Special Economic Zone Administrative Office building. Bidders who wish to attend may remain present at their discretion.
7. The Chairperson, Kandla SEZ Authority, reserves all rights to reject any one or all tenders.
8. Each bid shall be accompanied by a demand draft of Rs.20,000/- towards earnest money deposit, payable in favour of "Kandla SEZ Authority" payable at Gandhidham without which the bid will not be considered valid. In case the bidder withdraws his bid within the validity period, the earnest money shall be forfeited without assigning any reason whatsoever. EMD of unsuccessful bidder will be returned. The EMD will not bear any interest.
9. On getting intimation from KASEZ Authority, the successful bidder shall execute an agreement and furnish a bank guarantee or FDR from a scheduled bank equivalent to 10% of the total amount of the contract as Performance Security Deposit within the prescribed period which will be released only after successful completion of the contract period. EMD will be returned on receipt of the performance security deposit.
10. Penalty shall be recovered from the payment due to the vendor during the contract period for lapse of performance by the person deputed on duty such as non-availability at the given spot/area, absence from the duty, non-vigilance, etc. on proportionate basis equal to the amount of lapse of performance, etc.

11. No conditions should be added to the quotation.
12. The service provider shall be responsible for complying with all statutory requirements for providing its personnel with requisite facilities such as payment of minimum wages as per Govt.'s Minimum Wages Act, liability of weekly rest and leave, wages to the workers, etc.
13. Service provide shall ensure daily attendance of above said number of security personnel on 8 hours duty and also responsible for providing accommodation, transport, etc. as may be required.
14. KASEZ Authority has the right to increase/decrease the number of personnel.
15. The service provider should ensure police verification of character and antecedents of his staff and must furnish their identification proof like copy of election card or ration card duly attested by Gazetted Officer and countersigned by the service provider to the Security Officer at the time of actual deployment.
16. Service provider shall furnish a physical fitness in respect of all the personnel deployed, duly certified by a Registered medical practitioner.
17. Service provider shall ensure that the personnel deployed are within the minimum and maximum age limit prescribed for job in Central Government.
18. Since the persons engaged by the service provider shall be employees of the service provider, it shall be his duty to pay their wages every month and responsible for all statutory payments.
19. The service provider's personnel shall not divulge or disclose to any person any details of this office, operational process, technical know-how, security arrangements, administrative/organizational matters.
20. In case the service provider fails to perform or its performance is found to be unsatisfactory, the contract will be terminated by the Chairperson, KASEZ Authority giving one month's notice and the security deposit in that case shall be forfeited without assigning any reason.
21. There should be regular and proper checking of the performance of the personnel by the service provider.
22. KASEZ Authority will not pay any other charges.
