

It is informed that the Government of India has decided mandatory processing of the requests of the SEZ Developers and SEZ Units through SEZ Online System from 01.01.2015. In this regard, all the Developers and Units of Special Economic Zones in the State of Gujarat are requested to submit their requests/ intimations/ permissions under the SEZ Act and Rules relating to issuance of LoAs, extension of validity of LoAs and any other requests / intimations / permissions through SEZ online system (SOS) only w.e.f. 01.01.2015 to the concerned Development Commissioners, which means no applications / intimations /permissions will be accepted manually from 01.01.2015 onwards.

All respective Development Commissioners / Specified officers may kindly ensure smooth processing of such requests/ permissions / approvals in a time bound manner. It is also requested that Development Commissioners / Specified Officers and Developers may kindly ensure circulation of this Trade Notice to all SEZ Developers & units under their jurisdiction.
