

Minutes of the 1st Meeting (2017 Series) of the Units Approval Committee (UAC) for EOUs held on 03.02.2017 at 16:00 Hrs. at Central Excise Bhavan, Near Polytechnic Ambavadi, Ahmedabad under the Chairpersonship of ShriUpendraVasishth, ndc, Development Commissioner, KASEZ

M/S. ELYSIUM PHARMACEUTICALS LTD., VADODARA

The proposal is for establishment of a new unit under EOU at Near Padra – Jambusar State Highway, Village Dabhasa, TalukaPadra, District: Vadodara-391440, Gujarat for manufacturing of Pharma Products.

Shri Yashwant C. Patel, Chairman & Managing Director, of the company appeared before the UAC for personal interview and explained about the proposal. Shri Yashwant C. Patel gave a brief about their company and stated that M/s. Elysium Pharmaceuticals Ltd., was incorporated in the year 1995 as formulation unit. The Company commenced its manufacturing operations in the year 1997 and has 19th year of profitable operation. The company has developed and introduced various dosages more importantly for OTC (Over-the-counter) as well as for prescription market of USA. Now the company has proposed to set up a new manufacturing unit 2 kms away from existing plant which is a USFDA (United States Food and Drug Administration) compliant facility to cater the market for USA and Canada.

The Jt. Development Commissioner(i/c), City Office, Ahmedabad also made a site visit on 27.12.2016 and submitted his report to the Development Commissioner. He has stated in his report that the factory site has three separate buildings. The civil work of the construction of the buildings has been completed and the work of internal partition is going on. Further, out of the total plant and machinery to be procured; only the Air-conditioning plant has been received, but the same is yet to be installed. All other machinery is to be procured by the applicant and it has been informed that the work of procurement and installation will be finished within two months. JDC (i/c) opined that request of the applicant appears to be genuine and is recommended.

Observation/Decision of the Committee:

- Projected Export for the 5 year period is Rs 30498.00 lakhs
- Investment in Plant and Machinery will be Rs. 887.42 lakhs which will be procured indigenously.
- Net Foreign Exchange Earnings projected for the 5 year period is Rs. 29796.47 lakhs.

The proposal meets with the requirement of approval under EOU Scheme under the Automatic Approval Route. The Committee, therefore, decided to approve the proposal subject to standard terms and conditions.

M/S. TRUECARE BIOMEDIX, KHEDA

M/s. True Care BioMedix, Kheda is a working unit for manufacture and export of Rubbing Alcohol Filling Process and Pre-filled Syringe. The unit has requested for broad-banding of following additional products in their LOP: -

Shri Kamlesh Patel, Commercial Manager of the company appeared before the UAC and explained about their proposal.

It was observed from the process flow chart that they will be assembling, testing, Packaging and Sterilizing and they will not actually making of different parts from raw material. Though this activity as para 9.31 of FTP will be a manufacturing activity but copy of adhoc norms submitted by the company in respect of case No. 19/22/80/ALC 2/2011 of DGFT shall not be applicable in this case which is for manufacture of product from raw materials like PP granules, etc. It was thus observed that the EOU has to apply for fixation of input output norms at the earliest; DC will be able to approve adhoc norms only for six months. As stated by the unit's representative. They are having FDA approval for existing products and this new product they will export to US.

The Committee therefore, decided to approve the above new product for broad banding.
