Minutes of the 2<sup>nd</sup> Meeting (2014 series) of the Units Approval Committee(UAC) for EOUs held on 04-03-2014 at 12:15 Hrs. in the Office Chamber of the Development Commissioner, Administrative Building, Kandla SEZ, Gandhidham under the Chairpersonship of Shri Mahendra Jain, IAS, Development Commissioner, KASEZ.

## M/s. United Phosphorus(India) LLP, Bharuch :-

The proposal is for establishment of a new undertaking under EOU Scheme at Plot No. 3101/2, GIDC, Taluka- Ankleshwar, Bharuch for manufacturing of Agro Chemicals viz. Insecticides, Herbicides & Fungicides etc.

Shri R. Rajasekhar, Vice President-Commercial of the unit, appeared before the UAC for personal interview and submitted the following facts:-

- They have their unit in DTA and are in the business of Agro Chemical products for the last twenty years in the name of United Phosphorus Limited (UPL).
- They export their products to over 100 countries and their last year export was to the tune of around Rs. 2,200 Crores.
- The total export of Agro Chemicals products from India is around 6,000 Crores and their group contribute almost half of it.
- They want to give parallel export thrust to their business with exclusive Customs base for EOU and for that they are ready to take registration from the Central Insecticides Board and follow all the regulatory requirements under Insecticides Act, 1968.

## Observation/Decision of the Committee:-

- The projected FOB value of the exports for the next 5 years period is Rs. 1,97,375 Lakhs with total NFE of Rs. 41,034 Lakhs.
- The total investment in Plant & Machinery is Rs. 2,000 Lakhs.

- It was noted that the unit have not submitted any registration from the Registration Committee of the Central Insecticides Board for each and every insecticide they want to manufacture or import.
- After due deliberation, the UAC delegated the authority to the Development Commissioner, KASEZ to issue the LoP, once the unit is registered with the Insecticides Board and a proof to this effect is submitted to the DC office. In the mean time, a letter may be issued to the unit stating that the UAC has no objection to accept their proposal with the condition of submission of Registration Certificate issued under the relevant Act. Further, no separate UAC for this purpose will again be conducted.
- The proposal was approved under the Automatic Approval Route subject to standard terms and conditions.
