- 1) The sealed envelope should super scribe as "Offer for purchase of UPS System".
- 2) The Sealed envelope should be addressed to the Development Commissioner, Kandla Special Economic Zone, Gandhidham (Kutch) 370 230 and should reach the Inward Counter before 3.00 pm of 07-12-2015.

- 3) The bid/tender should accompany an Earnest Money of Rs.10,000/- in the form of DD/Banker's Cheque issued by any Nationalised/Scheduled Bank in f/o Regional Pay & Accounts Officer, Mumbai, payable at Gandhidham.
- 4) EMD will be refunded to unsuccessful bidders, without any interest, within a period of 15 days of finalization of the Purchase Order or cancellation/discharge of the tender. For successful bidder the EMD will be returned on receipt of the Bank Guarantee of a sum equivalent to 25% of the purchase value, which will be valid for a period extending two months from the warranty period.
- 5) The offer should be strictly as per the format given above. Incomplete offer or offer in other than the format given above shall be summarily rejected.
- 6) Vendor should submit self attested copy for Authorised Distributor of the brand for which they have quoted.
- 7) Bidder should submit self attested copy of VAT, Excise Registration and copy of PAN.
- 8) The warranty should be atleast 2 years which should include complete replacement in case of fault.
- 9) Each page of quotation should be signed by a Director/Partner/Sole Proprietor/Authorised Representative of the firm.
