Earlier, the Approval Committee in its 24th meeting held on 09-03-2016, while monitoring/reviewing Half Yearly Progress Report for the period ending September, 2015 (01-04-2015 to 30-09-2015), and Quarterly Progress Report for the third quarter up to 31-12-2015 filed by the Developer – M/s. GIFT SEZ Ltd., had noted and asked the Developer/Office of the Development Commissioner to place before it all pending QPR/HPR alongwith consumption/utilization statements with the respective Quarterly/Half Yearly Progress Report.
