A) Other cases:-

11-A-01) Request of the Developer (GIFT) for approval of goods required for Authorized Operations:-

Shri Surendra Prasad Srivastava, AVP (SEZ) of the Developer (GIFT), explained the requirement of goods for authorized operations sought vide their letter dated 13-06-2014. It was stated that the list of goods was for following default Authorized Operations as under, which are covered under Instruction No. 50 of the DOC:-

- Construction of all type of Buildings in processing area;
- Road with street lighting, signals and signage.

The Committee after due deliberation and diligence approved the list of goods for above default Authorized Operations subject to standard terms and conditions of the SEZ Rules, 2006.


11-A-02) Request of the Developer (GIFT) for allotment of space in the SEZ – processing area to the Postal Department, and M/s. Smart ICT Services Ltd:-

Shri Surendra Prasad Srivastav, AVP (SEZ) explained the requirement of providing premises/spaces to the 1) Postal Department and 2) M/s. Smart ICT Services Ltd., for providing respective services, in the Processing Area of the notified SEZ. The Committee after the discussions and deliberation was of the opinion that providing premises/space to service providers in the Processing Area of the SEZ, should be avoided, since the Processing Area of the SEZ is meant for manufacturing/service units for conduct of the approved Authorized Operations. Thus, the Committee advised the Developer to explore the possibility of providing porta cabins for the proposed service providers in the demarcated Non-Processing Area of the SEZ. The proposals was accordingly deferred.
