A) **Fresh proposal:-**


12-A-01) **Proposal of M/s. Globe Textiles Pvt. Ltd., Ahmedabad for setting up a new unit:-**

Shri Bhavik Parikh, Director of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of 1) Ready Garments; and, 2) Made-up (i.e. Lungi and Scarf)". The items proposed for manufacture are categorized as ready to wear.

- Proposed investment is Rs. 3186.58 lakh, and employment generation for 550 person;
- The Developer has earmarked four plots (38, 39, 40 & 41) for the proposed project. The applicant has committed to start basically readymade garmenting unit.
- Projected FOB value of exports is Rs. 27500.00 lakh with outgo of foreign exchange at Rs. 2425.00 lakh, resulting in NFE of Rs. 25075.00 lakh;

The Committee after due diligence and deliberation approved the project, subject to standard terms and conditions, of the SEZ Rules, 2006.
