**A) Fresh proposal:-**

**13-A-01) Proposal of M/s. Dheeraj Exports, Ahmedabad for setting up a new unit:-**


Shri Dheeraj Kankariya, Patner, and Shri Mahavir Kankariya representative of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of 1) Stitched Lungies; 2) Shirts; 3) Bermuda (Shorts); and 4) Trousers". The items proposed for manufacture are categorized as ready to wear.

- Proposed investment is Rs. 450.00 lakh, and employment generation for 200 person;
- The Developer has earmarked two plots (35 & 36) for the proposed project. The applicant has committed to start basically readymade garmenting unit.
- Projected FOB value of exports is Rs.7500.00 lakh with outgo of foreign exchange at Rs.75.00 lakh, resulting in NFF of Rs. 7425.00 lakh;

The Commissioner of Central Excise, Ahmedabad-I, during the discussions on the proposed project proposal had reservations on the Partnership Deed of the applicant company, regarding leasing of building/machineries in SEZ. The Committee directed the applicant to give written clarifications/explanations on leasing aspect.

The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006, and submission of clarifications/explanations by the applicant (M/s. Dheeraj Exports) as sought by the Committee.
