A) **Fresh proposals:-**

14-A-01) **Proposal of M/s. Kankariya Exports LLP, Ahmedabad for setting up a new unit:-**

Shri P. R. Kankariya, Partner of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of 1) **Stitched Lungies; 2) Shirts; 3) Barmuda (Shorts); and 4) Trousers**". The items proposed for manufacture are categorized as ready to wear.

- Proposed investment is Rs. 450.00 lakh, and employment generation for 125 person;
- The Developer has earmarked part of Plot No. 49 (6136.32 sq. mtrs) for the proposed project.
- Projected FOB value of exports is Rs.7500.00 lakh with outgo of foreign exchange at Rs.75.00 lakh, resulting in NFE of Rs. 7425.00 lakh ,over the period of 5 years
- The unit would start its commercial production after four to five moths after allotment of plot form GIDC.

The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006, and submission of source of funding for the project. DC instructed the unit to give employment preference to local persons.

14-A-02) **Proposal of M/s. Anmol International Ahmedabad for setting up a new unit:-**

Shri Rajeshkumar Jain, Proprietor of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of 1) **Stitched Lungies; 2) Shirts; 3) Barmuda (Shorts); and 4) Trousers**". The items proposed for manufacture are categorized as ready to wear.

- Proposed investment is Rs. 360.00 lakh, and employment generation for 125 person;
- The Developer has earmarked part of Plot Nos. 27, 32, 33, & 34 (3438 sq. mtrs) for the proposed project.

- The unit would start its commercial production after four to five moths after allotment of plot form GIDC.


The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006.
