

Minutes of the 25th (twenty-fifth) meeting of the Approval Committee for sector specific Ahmedabad Apparel Park – Special Economic Zone developed by Gujarat Industrial Development Corporation (GIDC) on 02-09-2016, at 1045 hours under the Chairmanship of Shri Upendra Vasishth, ndc Zonal Development Commissioner, Kandla Special Economic Zone, in the chamber of the Zonal Development Commissioner's office, Kandla-SEZ, Ahmedabad.

A) Fresh proposals:-

25-A-01) Proposal of M/s. Ecostitch, Ahmedabad for setting-up a new unit in GIDC Apparel Park, Ahmedabad.

Shri Chintan Shah, Partner of the applicant firm M/s. Ecostitch, appeared before the Approval Committee for personal interview. He explained their proposal for setting-up of a new manufacturing and export unit in GIDC Apparel Park, Ahmedabad. The proposal is for manufacture and export for:-

- 1) Cotton Canvas Tote (Bags) Hand Bag & Shopping bag of cotton & Sewn Textile Products (ITC HS Code – 63079020)
- 2) Narrow woven fabrics other than goods of heading 5807; Narrow fabrics consisting of warf without weft assembled by means of an adhesive (Bloducs) – of cotton or others- 58069 ITC HS Code – 58063120)
- 3) With outer surface of plastic and/ or textile materials – of cotton ITC HS Code – 63079020)
- 4) Other made up articles, including dress patterns. ITC HS Code – 63079020)
- 5) Woven fabrics of cotton, containing 85% or more by weight of cotton, weighing more than 200G/M2. 100% cotton dyed fabric/ cut parts (ITC HS Code- 52083190)
- 6) Aprons made from cotton other made up articles (ITC HS Code – 63079090)

A brief detail of the proposal is as under:-

- The FOB value for said project for 05 (five) years period is projected as Rs. 5450.00 lakhs, with foreign exchange outgo of Rs. 100.00 lakhs, resulting in NFE of Rs. 5350.00 lakhs (98.16%).
- The Developer, GIDC vide letter dated 11-08-2016 has earmarked, & confirmed allotment of Plot No. 47 in the SEZ for the proposed project.
