26-A-01) Request of M/s. Komal Texfab Pvt. Ltd., AAP-SEZ, for broad-banding of Letter of Approval (LOA) for inclusion of new items for manufacture and export:-

Shri Pramod Surana, Chief Manager, of the applicant company – M/s. Komal Texfab Pvt. Ltd., AAP-SEZ, appeared before the Committee for personal interview and explained the proposal for broad-banding to include additional/new items i.e. textiles and textile articles for manufacture and export to the existing LOA.

The Approval Committee was given to understand that the Government of India, in the Ministry of Commerce, vide letter No. D.12/45/2009-SEZ, dated 13-09-2013, with subject “Implementation of the SEZ (Amendment) Rules, 2013 – clarifications regarding” interalia, in Para-6 of the said letter clarified/defined sectoral broad-banding provisions for categories of sectors encompass similar/related area with each broad-band sector treated as a single sector, viz. ‘Textile, apparel, hosiery, fashion garments, wool and carpet’.

Further, the Approval Committee has taken note of letter No. F.2/20/2005-SEZ, dated 02-09-2016 issued by the Department of Commerce regarding change in sector of GIDC Apparel Park from ‘Apparel’ to ‘Textiles & Articles of Textiles’ (decided in 72nd meeting of Board of Approval for SEZs held on 12-08-2016).

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding, as well as change in sector in respect of GIDC Apparel Park, the Approval Committee after due diligence and deliberation approved the proposal of M/s. Komal Texfab Pvt. Ltd., AAP-SEZ for broad-banding of the existing LOA to include new items of “Made-up textiles articles” as per the list given in Annexure-A to the units’ application dated 13-07-2016 and also annexed to this minutes below, subject to standard terms and conditions, of the SEZ Rules, 2006.

26-A-02) Request of M/s. Globe Textiles (India) Pvt. Ltd., AAP-SEZ, for broad-banding of Letter of Approval (LOA) for inclusion of new items for manufacture and export:-

Shri Bhavik Parikh, Director, and Shri Manish Vyas, VP (Comm.), of the applicant company – M/s. Globe Textiles (India) Pvt. Ltd., AAP-SEZ, appeared before the Committee for personal interview and explained the proposal for broad-banding to include additional/new items i.e. textiles and textile articles for manufacture and export to the existing LOA. However, they could not explain that how they are going to manufacture items falling under Chapter-60 of ITC (HS). It was informed to the Approval Committee that at present they do not need broad-banding for Chapter-60 of ITC (HS) and therefore they want to withdraw for the same.

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding, the case being identical to Item No. 26-A-01, the Approval Committee after due diligence and deliberation approved the proposal of M/s. Globe Textiles (India) Pvt. Ltd., AAP-SEZ for broad-banding of the existing LOA to include new items of “Made-up textiles articles” as per the list given in Annexure-B to the units’ application dated 14-09-2016 and also annexed to this minutes below, subject to standard terms and conditions, of the SEZ Rules, 2006.


