**A) Other cases for GIFT - SEZ:-**

**05-A-01) Request of the Developer (GIFT) for approval of goods required for Authorized Operations:-**

Shri Nirav Patel, AVP – (F&A) of the Developer (GIFT), explained the requirement of goods for authorized operations. The Committee took-up the list dated 04-01-2013 furnished by the Developer (GIFT) for discussion. It was stated that the list of goods was for following default Authorized Operations as under, which are covered under Instruction No. 50 of the DOC:-

- Telecom and other communications facilities including internet connectivity

The Committee after due deliberation and diligence approved the list of goods for above default Authorized Operations subject to standard terms and conditions of the SEZ Rules, 2006.

**05-A-02) Request of the Developer (GIFT) for permission to sub-contract part of authorized operations in DTA under Rule-41 of the SEZ Rules, 2006:-**


The Committee noted the requirement of the Developer (GIFT) for removal of duty-free good (Bitumen) for preparation of the same into Dense Bituminous Macadam (DBM) and Bitumen Conerete (BC), this is required for authorized operation, i.e. construction of road in the notified SEZ. The Committee, approved the proposal, subject to following the prescribed procedures under the SEZ Rules, 2006, input-output norms, to the entire satisfaction of the Specified Officer of the SEZ.
