## 06-A-01) Project proposal of M/s. The MindLabs, Ahmedabad:-

Smt Nirja Shah, Proprietress of the applicant company appeared before the Committee for personal interview, and explained about the proposed project. The proposal is to set up a new service unit to provide services of "Information Technology Software Services".

Proposed investment is Rs. 22.00 lakh with employment generation of 8 persons;

Projected FOB value of exports is Rs. 3120.00 lakh, with foreign exchange outgo of Rs. 504.00 lakh, resulting NFE earnings of Rs. 2616.00 lakh (83.84%);

The Developer Ganesh-IT-SEZ has provided space for the proposed project in the Incubation Centre of the IT-SEZ, however no specific location/premises was given.

During the course of discussion it was brought to the notice of the Approval Committee that Developer – M/s. Ganesh Housing Corporation Ltd., had not earmarked proper and specific location/premises to the applicant to carry out the proposed activities from the SEZ as there is no space available in the current incubation center to take any new unit.

Thus, the Approval Committee directed the Developer – M/s. Ganesh Housing Corporation Ltd., to provide all necessary infrastructures including craving out of specific location/premises to the proposed new applicant in the SEZ. Wherein, the representative of the Developer Shri Dhaval Rao, pointed out that one of the approved/working unit viz. M/s. BrainTech Labs, is in the process of reducing the area allotted to them and that they shall move an application in this regard. This vacated space in the SEZ shall be allotted to the new applicant and the LOA shall be with this condition.

The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006, with no call centre activities/services, and further the developer provide specific location/premises in the SEZ to the applicant.
