07-A-02) Monitoring of Performance of SEZ units in Ganesh-IT/ITES SEZ, in respect of performance up to the monitoring year 2017-18.

This Approval Committee had granted approvals for 03 (three) entrepreneurs/units in Ganesh IT/ITES-SEZ, Ahmedabad, of which 03 (three) units were in operation as on 31-03-2018. In terms of provisions of Rule 22 of the Special Economic Zones Rules, 2006, these operational SEZ units are required to submit their respective Annual Performance Reports (APR) in prescribed format i.e. Form-I to the Development Commissioner and the same needs to be placed before the Approval Committee for consideration and review. The units have to submit their APRs duly audited and certified by independent Chartered Accountant appointed by the unit, and thereafter the said APRs have checked and verified by a Chartered Accountant (CA) appointed for the purpose of internal audit/test checks of APRs by the Office of the Development Commissioner, Kandla-SEZ.

The Approval Committee reviewed the APRs duly certified by the Chartered Accountant and audited/test checks by internal CA in respect of 03 (three) SEZ units as on 31-03-2018 i.e. for fiscal year 2017-18, which have positive NFE and the net result is as under. There is no case of negative NFE wherein penal action is required to be initiated in respect of any of the unit set up in Ganesh – TI/ITES-SEZ, Ahmedabad:-

the Developer Shri Dhaval Rao, President (IT) about the reasons slow down of exports and development of the SEZ to the Development Commissioner's Office which shall looked into and in case of manmade lapses action will be taken

Shri Dhaval Rao informed that they were making vigorous efforts to develop the SEZ but the project has not materialized as per expectation due to circumstances beyond their control, especially the IT sector in Gujarat, they are not in position to attract more entrepreneurs.

The Approval Committee was not satisfied with replies of the representative of Developer and directed them to submit the concrete and detailed plans immediately with time frame to full develop the notified IT/ITES-SEZ in order to fulfill the approval/notification stipulated conditions viz. to generate additional economic activities and employment in the SEZ. The Development Commissioner's office shall follow-up with the requirements, and reviewed in next meeting.
