
A) Fresh proposal:-

10-A-01) Proposal of M/s. She Girl India, Ahmedabad for setting up a new unit:-

Shri Bhagchand K. Anandani, Proprietor, of the applicant company appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal was for manufacture and export, of "1) Punjabi Suits; 2) Kurties; 3) Leggings". The Committee noted that the promoter of the applicant company had earlier obtained Letter of Approval (LOA) dated 22-08-2007 in the name and style of M/s. She Girl Apparels a proprietorship firm of Shri Bhagchand K. Anandani, which could not implement and start commercial production within the stipulated and extended time limit, thus the said LOA was treated as lapsed after over four years under Rule-19 (4) of the SEZ Rules, 2006, and Lapse Order was issued in April, 2012. Thereafter, the promoter applied a fresh in the name and style of M/s. She Girl India. The Committee felt this was to circumvent the SEZ Rules, and decided to refer the matter to the Ministry of Commerce & Industry, Department of Commerce for opinion as to whether fresh application can be consider for approval from the same set of promoter who has not implemented the earlier approval granted to them.

Therefore, the Committee decided to defer the said project proposal till the clarification is obtained from the Government.
