A) **Fresh proposal:-**

11-A-01) **Proposal of M/s. Balkrishna Textiles Pvt. Ltd., Ahmedabad for setting up a new unit:-**

Shri Nitin Thakkar, Managing Director of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of 1) Scarf; and, 2) Parios (Beach wear)".

- Proposed investment is Rs. 312.00 lakh, and employment generation for 35 person;
- The Developer has earmarked two plots (13 & 14) for the proposed project. Initially they will start with one plot in the SEZ.
- Projected FOB value of exports is Rs. 2585.00 lakhs with no outgo of foreign exchange, resulting in 100% NFE of Rs. 2585.00 lakhs;

The Committee after due diligence and deliberation approved the project, subject to standard terms and conditions, of the SEZ Rules, 2006, and submission of copy of Importer-Exporter Code number and Sales Registration.
