Minutes of the 19th (nineteenth) meeting of the Approval Committee for sector specific Ahmedabad Apparel Park – Special Economic Zone developed by Gujarat Industrial Development Corporation (GIDC) on 12-12-2014, at 1100 hours under the Chairmanship of Shri Vijay N. Shewale, ITS, Development Commissioner, Kandla Special Economic Zone, in the conference room of DC, Dahej – SEZ, Ahmedabad.

A) Fresh proposals:-

19-A-01) Project proposal of M/s. Stitchwell Garments, Ahmedabad for setting up a new unit:-

Shri Parag Fozdar, Partner, of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of "1) Shirts; 2) Aprons; 3) Gowns; and, 4) Industrial Garments'.

The Committee observed that the applicant is granted LOA dated 26-03-2014 for the same items of manufacture and export at Plot No. 13, in AAP-SEZ, Ahmedabad. The Committee observed that in the existing plot they are yet to commence the construction activity. The Committee was of the view that after the construction is completed, they can come up with a request for annexing the additional Area/Plot No. 14 to the existing LOA and there is no need for issuance of fresh LOA for similar activity. The Approval Committee therefore decided to reject the current application and advised them to come up with the request for annexing the area/plot to the existing LOA.

19-A-02) Project proposal of M/s. Worldwide Safety Pvt. Ltd., Kolkata for setting up a new unit:-

Shri Prashant Tulsyan, Director of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of "Seamless Knitted Gloves and Seamless Knitted dipped gloves in plastic".

- > Proposed investment is Rs. 2701.00 lakh, and employment generation for 450 person;
- > The Developer has earmarked Plot No. 48 for the proposed project.
- > Projected FOB value of exports is Rs. 225.00 crore, with foreign exchange outgo of Rs. 120.13 crore, resulting NFE earnings of Rs. 104.87 crore;
- ➤ The Committee asked the applicant to submit an undertaking that there is no case pending against them before the Development Commissioner, Falta-SEZ; Central Excise & Customs Department; Income Tax; DRI and DGCEI. This undertaking shall be submitted before execution of the Bond-cum-Legal Undertaking.

The Committee after due diligence and deliberation agreed to approve the project, subject to standard terms and conditions, of the SEZ Rules, 2006.

B) <u>Deferred case:</u>-

19-B-01) Project proposal of M/s. Shireeji Tex Fabs, Ahmedabad for setting up a new unit:-

Shri Ganeshmurthi Cinnaswamy, Partner, of the applicant company, appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for manufacture and export, of "Pyjamas and Tops for women".

The Committee observed that the applicant was lacking in financial arrangements for the proposed project in the SEZ. Thus, the Committee decided to defer the case, and asked the applicant to submit letters from their Bankers regarding the financial arrangements for the project in SEZ.

C) Other case:-

19-C-01) Request of M/s. Globe Textiles (India) Pvt. Ltd., AAP-SEZ, Ahmedabad for permission for trading of all kind of Textiles Fabrics, Grey Fabrics, Yarns, Made-ups, Readymade Garments:-

Shri Bhavik S. Parikh, Director, and Shri Manish Vyas, CEO, of the applicant company appeared before the Committee and explained their proposal for trading of above requested items. The Committee observed that they already have approval for manufacture and export of 1) Readymade Garments; and 2) Made-ups (i.e. lungi and scraf). The Committee was not convinced about the proposal for trading of the goods in same commodities put forth by the unit and decided to reject the application.
