A) Fresh Case for Aqualine IT/ITES -SEZ:-


20-A-01) Proposal of M/s. Patni Computer Systems Ltd., Aqualine – IT –SEZ, for change of name:-

Shri Vijay Rego, Authorized representative of the Company explained their proposal for change of name from M/s. Patni Computer Systems Ltd., to M/s. Igate Computer Systems Ltd., as per the corporate decision.

The Committee after due diligence and deliberation approved the above proposal subject to normal conditions, of the SEZ Rules, 2006, like execution of fresh Bond-cum-LUT in the new name.

The representative of the Developer (Aqualine) pointed out to the Committee, that the Service Tax Commissionerate requires annual approval of the list of services (default) once approved by the Approval Committee. The Development Commissioner (DC), directed the JDC to take-up the issue with the Service Tax Commissionerate, and to clarify the matter regarding the purpose of default list of services, wherein the SEZ Developer and unit do not have to approach this Committee every year for approval of list of services.
