

Minutes of the 22nd (twenty-second) meeting of the Approval Committee for sector specific Ahmedabad Apparel Park – Special Economic Zone developed by Gujarat Industrial Development Corporation (GIDC) on 09-03-2016, at 1730 hours under the Chairmanship of Shri Upendra Vasishth, ndc Zonal Development Commissioner, Kandla Special Economic Zone, in the conference room of the Developer i.e. GIFT SEZ Ltd., Gandhinagar.

A) **Fresh proposals:-**

22-A-01) Proposal of M/s. Krushna Casual Wears Pvt. Ltd., Ahmedabad for setting-up a new unit in GIDC Apparel Park, Ahmedabad.

Shri Bhavesh Gandhi – Director of the applicant company M/s. Krushna Casual Wears Pvt. Ltd., appeared before the Approval Committee for personal interview. They explained their proposal for setting-up of a new manufacturing and export unit in GIDC Apparel Park, Ahmedabad. The proposal is for manufacture and export for:

1. Denim and Jeans
2. Trousers

A brief detail of the proposal is as under:-

- The FOB value for said project, for 5 (Five) years period is projected as Rs.1648.38 lakhs, with no foreign exchange outgo, resulting in NFE of Rs.1648.38 lakhs (100%).
- The Developer, GIDC-AAP-SEZ has entered in to lease deed agreement dated 11-10-2007, for Plot No.12 in the SEZ for the proposed project, with the applicant.

The Committee noted that the applicant were earlier issued LOA 27-08-2007 the same was not implemented and thus it is treated as lapsed under the SEZ Rules. Thereafter, the Approval Committee after due diligence and deliberation approved the current project, subject to standard terms and conditions, of the SEZ Rules, 2006, and clearance of all other related aspects with the Developer (GIDC) including legal dues, etc. and on the basis of fresh no objection and/or earmarking letter for Plot No. 12 in AAP-SEZ, by the Developer (GIDC).

24-A-02) Request of M/s. Stichwell Garments, AAP-SEZ, for broad-banding of Letter of Approval (LOA) for inclusion of new items for manufacture and export:-

Shri Parag Fozdar, Partner, of the applicant company – M/s. Stichwell Garments, AAP-SEZ, appeared before the Committee for personal interview, and explained the proposal for broad-banding to include new items i.e. made-ups (Textiles & Articles of Textiles) for manufacture and export to the existing LOA.

The Approval Committee was given to understand that the Government of India, in the Ministry of Commerce, vide letter No. D.12/45/2009-SEZ, dated 13-09-2013, with subject “Implementation of the SEZ (Amendment) Rules, 2013 – clarifications regarding” interalia, in Para-6 of the said letter clarified/defined sectoral broad-banding provisions for categories of sectors encompass similar/related area with each broad-band sector treated as a single sector, viz. ‘Textile, apparel, hosiery, fashion garments, wool and carpet’.

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding, the Approval Committee after due diligence and deliberation approved the proposal of M/s. Stitchwell Garments, AAP-SEZ for broad-banding of the existing LOA to include new items of “Made-up textiles articles” as per application dated 31-08-2015, subject to standard terms and conditions, of the SEZ Rules, 2006.
