27-A-01) Project proposal of M/s ET Elastomer Technik India Pvt. Ltd., Gandhinagar

Shri Dharmesh Patwa – Director and Shri Hardik Patwa – Financial Manager of the applicant company M/s. ET Elastomer Technik India Pvt. Ltd., again appeared before the Committee for personal interview. The proposal is regarding setting up of service unit to provide services for “1) **Manufacture and export of Silicon Moulded Articles/Parts.**” The representatives of the applicant company were very vocal and requested the Approval Committee to consider and approve their project proposal.

The Approval Committee was given to understand that the Government of India, in the Ministry of Commerce, vide letter No. D.12/45/2009-SEZ, dated 13-09-2013, with subject “Implementation of the SEZ (Amendment) Rules, 2013 – clarifications regarding” interalia, in Para-6 of the said letter clarified/defined sectoral broad-banding provisions for categories of sectors encompass similar/related area with each broad-band sector treated as a single sector, viz. ‘IT, ITES, Electronic components and hardware manufacturing, non-conventional energy, BPO (including legal, medical and similar services), KPO and R&D’.

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding, the Approval Committee after due diligence and deliberation approved the project proposal of M/s. ET Elastomer Technik India Pvt. Ltd. for manufacture and export of “Silicon Moulded Articles/Parts” subject to standard terms and conditions, of the SEZ Rules, 2006, and on the specific undertaking of the applicant that the manufactured goods in the SEZ shall basically for the electronic industry only.
