Minutes of the 4th Meeting (2015 Series) of the Units Approval Committee (UAC) for monitoring of performance of EOUs held on 17.07.2015 at 2:30 Hrs. at Central Excise Bhavan, Ahmedabad, under the Chairpersonship of Shri Krishan Kumar, Jt. Development Commissioner, KASEZ

Monitoring of performance of 100% EOUs:

Monitoring of performance of EOUs falling under the jurisdiction of following Commissionerate for the period 2009-10 to 2013-14 were taken up for review:

- 1. Ahmedabad-I Commissionerate.
- 2. Ahmedabad-II Commissionerate.
- Ahmedabad-III Commissionerate.

(a) Ahmedabad-I Commissionerate

It was noted that at present there are 12 working units, all the units have achieved positive NFE.

Shri Jatin Shah and Hemant Rathod, the representatives of M/s. choksi colours Pvt. Ltd. and Choksi organics Pvt. Ltd. attended the meeting and stated that the Central Excise authority is charging excise duty on the empty packing material.

Shri S.H. Mandalia, Asstt. Commissioner (Tech), Central Excise, Ahmedabad-I has replied to the unit that they have to pay the duty on the empty packing material. The unit was requested to refer the case in writing to Central Excise Authority with a copy to office of the Development Commissioner, KASEZ.

(b) Ahmedabad-II Commissionerate

It was noted that at present there are 25 working units, 24 units have achieved NFE while one unit M/s. Bitscape IT Solution Pvt. Ltd. has not submitted the APRs. Show Cause Notice has already been issued to the unit for non-submission of APRs.



Shri G.M. Chauhan, Asstt. Commissioner, Central Excise, Ahmedabad-II Commissionerate has informed that the said unit has surrendered their license in 2011. J DC desired that the Excise deptt. Should furnish details and the process of exit in proper way should take place.

Shri Vinod Kothari, Managing Director of M/s. Synpol has also attended the meeting and stated that CERA has raised the objection to allow concessional rate of excise duty for DTA clearance on goods similar to those which were exported. He has also stated that the Central Excise authority is charging excise duty on the empty packing material/M.S. Drums of imported raw material/inputs etc, which were sold in DTA.

The Jt. Development Commissioner requested him to make a reference to office of the Development Commissioner, KASEZS so the issue could be properly examined in consultation with Central Excise Authority.

Shri Shriram Zodpe, Manger of M/s. Adgums Pvt. Ltd. has attended the meeting and stated that their work is going on smoothly and they do not have any problem.

(c) Ahmedabad-III Commissionerate

It was noted that at present there are 19 working units, out of which 02 units M/s. Jhawar Alumax Pvt. Ltd. and M/s. Lucent Clean Energy Pvt. Ltd. achieved negative NFE in the 1st year and 2nd year of 1st block period (2012-13 and 2013-14). Committee noted that no action is required to be taken at this stage. However, a letter to these units may be issued to advise them to make efforts to achieve positive NFE and the units be kept in watch list.

Shri Rahul Mewadr, Manager of M/s. ET Elastomer Technic India Pvt. Ltd. and Shri Jayaprakash M., Production Manager of M/s. Gujarat Microwax Pvt. Ltd. attended the meeting and stated that they do not have any problem and they have achieved positive NFE.

The meeting ended with a vote of thanks to all.
