Monitoring of performance of 100% EOUs:

Monitoring of performance of EOUs falling under the jurisdiction of Bhavnagar Commissionerate for the period 2009-10 to 2014-15 were taken up for review.

1. It was noted that none of the units which completed 5 years block period during the years of review was NFE negative for the 5 year block as a whole or for the first 4 year of 5 year block period. So on account of NFE, none of the unit was required to be issued SCN as per the instructions.
2. The representatives of EOUs expressed their satisfaction with Central Excise as well as DC, KASEZ office. Specially on being about refund of Cenvat Credit, it was mentioned that they have no problem with refund.
3. However, in respect of M/s. Chhatariya Dehydrates Exports an export realisation of US \$ 20807.50 was pending, the Committee decided to issue SCN and take appropriate action. JDC, KASEZ requested concerned Central Excise officer to furnish present email, postal address and telephone number of the unit, as the Central Excise officer had informed that the unit is still functional as a DTA unit.
