Minutes of the 14th, 15th and 16th Meeting (2016 Series) of the Units Approval Committee (UAC) for EOUs for monitoring of performance of EOUs held on 17.11.2016 at 15:00 hrs, 15:30 hrs and 16:00 hrs respectively at Central Excise Bhavan, Ahmedabad under the chairmanship of Shri Krishan Kumar, Joint Development Commissioner, KASEZ

Monitoring of Performance of 100% EOUs

Monitoring of performance of 100% EOUs falling under the jurisdiction of following commissionerates for the period 2014-15 to 2015-16 was taken up for review.

- 1. Ahmedabad-I Commissionerate
- 2. Ahmedabad-II Commissionerate
- 3. Ahmedabad-III Commissionerate
- 2. The meetings were held one after another. In meetings, representatives of certain units pertaining to three commissionerates were also present. On the statements prepared commissionerates wise by DC office, it was pointed out by excise officer that jurisdiction shown was not correct in respect of certain units, so common minutes have been prepared.

It was decided that each commissionerate may send a list of EOUs (active and inactive both) falling under their jurisdiction to DC office for reconciliation.

3. The Monitoring Committee monitored NFE status of the units for the year 2014-15 and 2015-16 and all the units listed were found to be positive except **M/s Lucent Clean** which after completion of Four years was NFE negative. It was informed by JDC, SCN will be issued to the unit.



4. Following Units were identified with no activity/ the unit that have not submitted APRs.

It was decided that Central Excise Office and DC Office will send reports about present status of the units to each other.

- 5. The Committee also noted that following EOUs namely a) M/s Asiatic Colour Chem. Ind. Ltd. b) M/s Trivedi Tectonics had foreign exchange unrealized as on 31.03.2016 beyond permissible period. It was informed by JDC that SCNs will be issued to the units concerned as per provision of para 2.54 of FTP 2015-2020.
- 6. Various issues raised by the units' representative were clarified/addressed to by officers from DC Office/ Central Excise Commissionerates.
- 7. Joint Development Commissioner, Kandla SEZ mentioned that many of EOUs don't have Input-Output norms duly ratified by a Norms Committee (NC) in DGFT which is necessary if their products that are not covered under SION or if wastage is not less than 2% (in terms of value & quantity both). Such units should make serious efforts to get input-output norms fixed/ratified from Norms Committee concerned in DGFT; continuation of ad-hoc permission from DC' Office will not suffice and ultimately norms are to be fixed by NC concerned. He requested representative of Central Excise also to look into this aspect, as central excise has day to day interaction with the units.

The meeting ended with a vote of thanks to all.
