

Minutes of the 13th Meeting (2016 Series) of the Units Approval Committee (UAC) for EOUs held on 17.11.2016 at 12:00 Hrs. in the Office Chamber of the Development Commissioner, Administrative Building, Kandla SEZ, Gandhidham under the Chairpersonship of Shri Upendra Vasishth, ndc, Development Commissioner, KASEZ

The proposal is for conversion of their existing DTA unit into EOU at E/12, GIDC Industrial Estate, Village Manjusar, Taluka Savli, Dist.-Vadodara-391 775, Gujarat, for manufacturing of Plastic Carry Bags.

Shri Rajendran K. R., Export Manager and Shri Shiv Kumar, Deputy Manager of the company appeared before the UAC for personal interview and explained about the proposal. Shri Rajendran K. R. gave a brief about their company and stated that company is registered on 27th March, 1995 and they are registered under Small Scale Industry (SSI). They are manufacturing plastic carry bags and other plastics films, rolls, tubes etc. made from blown film (Extrusion) technology. They are using polyethylenes, masterbatches and other necessary additives. They have leasehold land, factory building, Plant and Machinery. They have annual manufacturing capacity of 3000 metric tons of plastic carry bags. They are currently availing benefits of chapter 4 of Foreign Trade Policy.

On being pointed out by the Chairman as to why they want to convert their existing DTA unit into EOU, Shri Rajendran stated that they have established name in West African countries having various products as Merchant Exporter. They have an experienced marketing team to sell their products. Plastic Carry Bag is regular selling product which has very huge demand all over the world. They have focused in their traditional market "West African Region". They also manufacture "Bio De-gradable" plastic carry bags.

Observation/Decision of the Committee:

- Projected Export for the 5 year period is Rs 13534.00 lakhs
- Net Foreign Exchange Earnings projected for the 5 year period is Rs. 3759.52 lakhs.

The proposal meets with the requirement of approval under EOU Scheme under the Automatic Approval Route. The Committee, therefore, decided to approve the proposal subject to standard terms and conditions and also subject to physical inspection of factory site by jurisdictional Central Excise office.
