- 3) The bid/tender should accompany an Earnest Money of Rs.10,000/- in the form of DD/Banker's Cheque issued by any Nationalised/Scheduled Bank in f/o Regional Pay & Accounts Officer, Mumbai, payable at Gandhidham.
- 4) EMD will be refunded to unsuccessful bidders, without any interest, within a period of 15 days of finalization of the Purchase Order or cancellation/discharge of the tender. For successful bidder the EMD will be returned on receipt of the Bank Guarantee of a sum equivalent to 25% of the purchase value, which will be valid for a period extending two months from the warranty period.
