
A) Other proposals:-

17-A-01) M/s. Famy Care Limited; Zydus – Pharma – SEZ – Request for amplification/broad-banding of LOA under Rule-19:-

Shri Jagannathachar S. R., DGM – Finance & Commercial appeared before the Committee and explained their fresh broad-banding proposal for manufacture and export of “Ferrous Fumerate tablet”.

- LoP was issued to the Unit for manufacture of following products:
 - 1) Hormone based OCP (Oral Contraceptive Pills) Tablets, including combipack of (a) Hormone +Ferrous fumerate, Placebo tablets, (b) Oral Contraceptive Pills + Ferrous Fumerate /Placebo tablets;
 - 2) Hormone based Oral Contraceptive Pills, injectables - (a) Vials, (b) Ampoules; & Service activity i.e. Development of product, and/or sale of Dossier.
 - 3) Contraceptives, medical devices, including Copper-T.
 - 4) Mifepristone and Mifepristole Tablets
 - 5) Artemether & Lumefantrine (anti-malaria) Tablets.
- Unit has commenced commercial production with effect from 01/05/2009 and exported goods worth Rs. 106.42 crore on cumulative basis as on 31/03/2011 with Positive NFE. They have made an investment of about Rs. 45.83 crore for Plant and Building in the SEZ and have generated direct employment for 172 people and 243 people on indirect basis.
- It was explained that presently unit is manufacturing combipack of Oral Contraceptive Pills + Ferrous Fumerate/Placebo tablets in one packet however some clients want separate Ferrous fumerate Tablets. Hence, unit wants to manufacture Ferrous fumerate Tablets separately. It was stated that existing manufacturing line would be used for the same. There will not be any additional investment/ employment and no need for separate clearance from pollution control board is required.

After due deliberation and diligence, the Committee approved inclusion of additional item sought by the applicant to their existing LOA, subject to standard terms and conditions of the SEZ Rules, 2006.
