

Minutes of the 18th (eighteenth) meeting of the Approval Committee for sector specific Pharmaceuticals – Special Economic Zone developed by M/s. Zydus Infrastructure Pvt. Ltd., held on 28-03-2012, at 1530 hours, under the Chairmanship of Shri Pravir Kumar, IAS, Development Commissioner, Kandla Special Economic Zone, in the conference room of DC's Office, Dahej – SEZ, Ahmedabad.

A) Other proposals:-

18-A-01) M/s. Amneal Life Sciences Pvt. Ltd; Zydus – Pharma – SEZ – Request for inclusion of additional service in the default list of taxable services:-

Shri Girish Hirpara, Manager – Excise, appeared before the Committee and explained their request for inclusion of additional service viz. “Renting of immovable property” in the default list of taxable services prepared by the DC, Dahej – SEZ. The Committee found that the applicant had rented office premises from the developer in the non-processing area of the SEZ.

The Committee did not arrive at any conclusion, whether the services consumed in the non-processing area of the SEZ can qualify for exemption and/or refund (as the case be). Therefore, after deliberations, the Committee advised the Development Commissioner to take-up the said issue with the Competent Authority (BOA) for necessary clarification/direction in the matter.

18-A-02) M/s. Cadila Healthcare Ltd; Zydus – Pharma – SEZ – Request for amplification/broad-banding of LOA under Rule-19:-

Shri Rakesh K. Sinha, General Manager appeared before the Committee and explained their request for broad-banding proposal to manufacture and export of additional items viz. “a) anti-infectives; b) anti-malarials; c) anxiolytics; d) anti-coagulants; e) anti-platelet agents; f) gastrointestinal agents; g) analgesics; h) antibiotics; i) anti-convulsants; j) antienatic agents; k) cardiovascular agents, such as anti antihypertensives, antanginal, anti arrhythmic diuretics, etc; l) anti-diabetic; m) anti-virals; n) respiratory agents, such as anti-asthmatic, etc; o) oncocare tablets & capsules; and p) anti-thyroid, and R&D service activity – “development process to manufacture above products and its analytical method”.

After due deliberation and diligence, the Committee approved inclusion of additional items sought by the applicant to their existing LOA, subject to standard terms and conditions of the SEZ Rules, 2006.

18-A-03) M/s. Famy Care Limited; Zydus – Pharma – SEZ – Request for amplification/broad-banding of LOA under Rule-19:-

Shri Jagannathachar S. R., DGM – Finance appeared before the Committee and explained their request fresh broad-banding proposal for “Research and Development (R&D) activity”.

After due deliberation and diligence, the Committee approved inclusion of additional item sought by the applicant to their existing LOA, subject to standard terms and conditions of the SEZ Rules, 2006.

18-A-04) M/s. Fisher BioPharma Service (India) Pvt. Ltd; Zydus – Pharma – SEZ – Request for destruction of clinical trial supplies, drugs, laboratory waste, packing materials, etc:-

Ms. Neru Ranjan, Director appeared before the Committee and explained their request for destruction of used goods in SEZ. The Committee noted that no approval/clearance of the Approval Committee was required for the proposed activity. Accordingly, they were advised to follow the stipulated procedures as per SEZ Rules. The Committee also discussed their proposal for expansion in SEZ, by transfer of business activities from their Bangalore facility (DTA) to SEZ. The Committee observed that this was permitted, subject to the standard terms and conditions of the SEZ Rules, 2006, and the procedures contained in DOC's Instruction No. 11, dated 12-08-2009, regarding procurement of used capital goods from DTA by SEZ units.
