Ltd., held on 02-05-2014, at 1100 hours, under the Chairmanship of Shri Mahendra Jain, IAS, Development Commissioner, Kandla Special Economic Zone, in the conference room of DC's Office, Dahej – SEZ, Ahmedabad.

The Committee perused the above list of services and heard the explanations from the representative. It was observed by the Committee that majority of the services requested by the units of Zydus – SEZ are broadly incorporated in the default list of (60) services published by the Department of Commerce but, since the service provider to the pharma units of SEZ are registered with a different service, they have requested for the same.

Thereafter, the representatives from Zydus were asked to explain the requirement of services which are exclusively required for the authorized operation of the units in a Sector Specific Pharmaceutical SEZ and not included in the default list of (60) services. In response, the representatives elaborated the requirement of the following services required exclusively for a pharma unit.

- Air Travel Agent Service at serial no. 1 of the above list of services is approved by the Committee as the representative explained that their employees have to travel abroad for marketing. While approving the service the Committee decided that the exemption shall be limited to a list of employees. Accordingly all the units based in Zydus SEZ shall provide a list of employees who have been endorsed by their respective managements for travel with respect to the authorized operations of the SEZ units.
- Dry Cleaning Service at serial no. 11 of the above list is approved by the Committee as the requirement of sterilized clothing is a must as per the Good Manufacturing Practices by various Pharm Regulatory Authority.
- Health Service at serial no. 17 of the above unit is approved by the Committee, as health check-ups and certification by qualified Doctor is mandatory requirement as per Good Manufacturing Practices. The services will be allowed exemption only if they are conducted inside the SEZ premises. Further, the service provider shall certify in the Bill that the health check up has been conducted as per the parameters of GMP.
- Forward Contract Services at serial no. 15 approved by the Committee as
 the pharma units avail such services for better profitability by securing the
 foreign exchange rates in advance.
- Hotel, Inn, Club and Guest House Services at serial no. 18 approved by the Committee as it was explained by the representative that they have to undergo pharma audits and inspections conducted by various Pharma Regulatory Authorities, technical support from officials of the suppliers for installation of machinery/materials purchased from abroad and the

SEZ unit has to provide lodging and boarding facilities to all such foreign officials. The Committee approved the services only for providing stay facilities to officials of Regulatory Authorities and Officials from overseas supplier of goods.

 Medical Records maintenance service at serial no. 24 approved by the Committee as it was explained by the representative that they have to safe keep the products during Research as per the norms set by Pharma Regulatory Authority.
