A) Deferred proposal:-

43-A-01) Request of M/s. Intas Pharmaceuticals Ltd., Zydus-Pharma-SEZ, for amendment, broad-banding of their LOA for inclusion of additional items for exports:

Shri Mukesh Bothra, DGM – R&D, and Shri Krunal Shah, Manager of M/s. Intas Pharmaceuticals Ltd., appeared before the Approval Committee for presentation of their case and explained their proposal in detail, which are as under:-

1) Annual Capacity enhancement of approved items to the LOA:-

Originally, the above items were approved vide Letter of Approval dated 08/11/2007 and now, there is enhancement in annual production capacity as presently the applicant has installed 4 production lines for manufacture of injectable/parenteral and 1 line for gel production, installed in their plant located on Plot No.5 to 7. The applicant as a part of future exports prospects, has decided to go for product diversification and capacity enhancement and accordingly, they have decided to install the 30 production lines for tablets/capsules (orals) and 6 lines for injectable/parenteral at Plot No.8 to 12 of SEZ. Applicant vide letter dated 23/12/2017 has submitted proposed investment for expansion of SEZ project and proposed export and proposed employment after expansion of their SEZ plant.
