
Approved minutes of the previous meeting were confirmed by the Approval Committee.

A) Other proposal:-

48-A-01) Request of M/s. Amneal Pharmaceuticals Pvt. Ltd., Zydus-Pharmaceutical-SEZ, Matoda, Ahmedabad, for addition of land area to the existing allotted plots in SEZ.

Shri Rahul Tambi, Sr. GM, Finance & Accounts, Shri Satyajit Naik, AGM, Finance & Accounts, and Shri Pratik Mehta, Sr. Manager – Corporate Affairs, of M/s. Amneal Pharmaceuticals Pvt. Ltd., appeared before the Approval Committee and explained their requirement of additional land area admeasuring 20969.08 square meters which was in principally allotted by the Developed – M/s. Zydus Infrastructure Pvt. Ltd., within the Plot Nos. 16 & 17. After this addition sought the total land area for Plot Nos. 15, 16, & 17 shall be 68,732.60 square meters. This is required by SEZ unit for various logistics reasons for their captive use.

After due deliberation and diligence the Approval Committee gave its unanimous consent to the request of the SEZ unit viz. M/s. Amneal Pharmaceuticals Pvt. Ltd., for inclusion of an additional land area admeasuring 20969.08 square meters, subject to normal condition that both the SEZ Developer and the unit shall enter into additional/supplementary Lease Deed as required under Rule-18 (2) (ii) of SEZ Rules, 2006.
