

22-A-01) Request of the Developer and units of GIDC – Electronic/IT-ITES - SEZ for approval of default list of taxable services, and addition of new services required in SEZ:-

The Chairman informed the Committee that the default list of 60 + 3 services has been issued by Kandla – SEZ for all SEZs in Gujarat in order to bring uniformity, and many of the services sought by various SEZ developers and units fall under the broad category of the default list. The Committee took up the additional list of services sought by the units in GIDC-EP-IT/ITES –SEZ, and after due diligence and deliberation approved the following services, for exclusive use of the said services within the SEZ:-

- Event Management;
- Forward Contract Service – limited to import & export of goods and services (Authorized Operations).
- Management Consultant.
- Health services undertaken by hospital or medical establishment – limited only to SEZ.
- Restaurant services – limited to catering services provided within the SEZ for business meetings.
- Hotel, Inn, Club, and Guest House services – Deferred. The Committee requested the unit to submit fool proof system of checks for availment of the service.
