23-A-01) **Project proposal of M/s. Login Infocom Pvt. Ltd., Ahmedabad:-**

Shri Ritesh Vala, Accounts Manager, and Shri Rohan Thakkar, CA, of the applicant company appeared before the Committee for personal interview. The proposal is regarding setting up of service unit to provide services for "1) Computer keyboard testing; 2) Computer scanner testing; 3) Computer mouse testing; 4) other computer parts testing; 5) computer hard-disc testing; 6) computer removable or exchangeable disc drives testing; and, 7) computer testing of other units of automatic data processing machines". The representatives of the applicant company were unable to explain the exact nature and the objectives of the proposed project, the equipment & machineries to be used, etc.
