
The proposal is to set up a unit for manufacture and export of following products "1) Computer numeric control intra ocular lens haptic forming machine for Intra Ocular Industry; 2) Computer numeric control intra ocular lens haptic forming machine for Intra Ocular lens/Contact Lens Industry; 3) Robotics Arm upto 3 Axis; 4) Image Processing based slit lamp for ophthalmic surgeon; 5) Computer numeric control dental implant contouring machine for dental industry; 6) Image processing based dental implant scanner; 7) Focal length measuring electronic bench for intra ocular industry; 8) Ultra sonic tank cleaning for various industry; 9) Liner motion directive drive upto 0.005 micron; 10) Medical Devices/Intra Ocular Lenses.

Proposed investment is Rs. 600.00 lakh, with employment generation for 90 persons;

Projected FOB value of exports is Rs. 14000.00 lakh with outgo of foreign exchange at Rs. 6329.00 lakh, resulting NFE of Rs. 7671.00 lakh over a period of 05 (five) years.

It was confirmed by JDC that all above items are 'Free' as per ITC-HS Codes.

The Committee after due diligence and deliberation approved the proposal, subject to standard terms and conditions of the SEZ Rules, 2006.
