A) Fresh Proposal:-

30-A-01) Proposal of M/s. C.S. Laser LLP., Gandhinagar, for setting-up a new unit in GIDC's Electronic Park - SEZ, Gandhinagar.

Shri Arvindbhai Patel, Partner of the applicant firm appeared before the Approval Committee and explained their proposal for setting-up of new unit in GIDC's Electronic-SEZ, Gandhinagar, for manufacture of "**Fiber Coupled Diode Laser Modules – ITC No. 90139090**". A brief detail of the proposal is as under:-

- The FOB value for said project, for 5 (Five) years period is projected as Rs.4248.00 lakhs, with foreign exchange outgo of Rs.2931.00 lakhs resulting in NFE of Rs.1317.00 lakhs (31%).
- The Developer (GIDC) is in agreement with the proposal of the applicant to operate this project from the 2nd (second) floor of factory building of M/s. Sahjanand Laser Technology Ltd., set-up on Plot Nos. 28, & 29 in the SEZ on sub-lease basis.

The Committee after due diligence and deliberation approved the project, subject to standard terms and conditions, of the SEZ Rules, 2006, and the applicant submits the list of inputs required the project with ITC (HS), and use of premises by way of sub-lease basis on Plot Nos. 28 & 29 in SEZ shall be with separate/secluded entry and exit points for both units to the entire satisfaction of the Specified officer of the SEZ.


B) Other Proposals:-

30-B-01) Approval of additional services to the default list of services by units namely M/s. Eurocircuits India Pvt. Ltd., and M/s. PCB Planet India Pvt. Ltd., of GIDC – Electronic/IT -SEZ

Shri Manish Panchal, under authority from both the units appeared before the Approval Committee and explained their request for approval of three (03) more services viz. 1) Air Travel Agent Service; 2) Business Auxiliary Service; and 3) Business Support Service.
