### TENDER NOTICE

Chairman, Kandla SEZ Authority invites tenders for conducting Fire Audit in the Units set up in Kandla Special Economic Zone. The scope of work of Fire Audit is given as under:-

#### **A. SCOPE OF WORK FOR FIRE AND SAFETY AUDIT**

The auditing agency will carry out thorough safety audit of all the used clothing and plastic units situated inside the zone as per the 31 elements of IS 14489 “A code of Practice for Safety Audit”, Fire prevention and control system, ventilation system, emergency preparedness, evacuation system and safety management. The fire and safety audit agency will mainly focus upon the following points:-

- (a) Physical inspection of plants accompanied by the plant personnel.
- (b) Discuss the fire safety norms and its hazards with the company officials.
- (c) Audit will be as per NBC (National Building code).
- (d) Gujarat Fire Prevention and life safety measure Act 2013 and Rules 2014 will be followed.
- (e) NFPA guidelines will be followed.
- (f) IS 14489 – A guide for occupational safety and health audit will be followed.
- (g) The Factory Act and State Factory Rules with other applicable OHS regulations will be followed.
- (h) The Fire and safety audit report alongwith recommendations.
- (i) After audit, Briefing/presentation to be made to Officers of Kandla SEZ on OHP. Fter this presentation based on input of Kandla SEZ Officers, report will be finalized within 2 weeks.

#### **B. OBJECTIVES OF FIRE & SAFETY AUDIT**

The main objectives for conduct of fire and safety audit are as under:-

- (a) Identification of significant hazards.
- (b) Evaluate the existing safety measures
- (c) Determine the additional control measures.
- (d) Examine the availability of suitable emergency plan detailing responsibility and action of key personnel.
- (e) Evaluate the general awareness of plant/security personnel on matters relating to fire safety and rescue operations.
- (f) Evaluate the training and instructions on fire and safety imparted to the employees.
- (g) Testing of all fire & safety equipment and systems.

Other terms and conditions of the tender is given as under:-

1. The Fire Audit will be undertaken initially in the units engaged in worn and used cloth sector and also in the units engaged in recycling of plastic waste/scrap. This will include warehousing units that have provided space to worn & used clothing units. There are multiple allotments of premises to a single unit is given.
2. An Earnest Money Deposit of Rs.25,000/- (Rupees twenty five thousand only) by way of DD drawn in favour of "Kandla SEZ Authority" payable at Gandhidham, shall be submitted alongwith the tender. The EMD of unsuccessful bidder will be returned and that of the successful bidder will be released only after submission of the final report.
3. The Agencies participating in the bid should be registered either with Gujarat State Disaster Manager Authority or Directorate of Industrial Safety and Health or any such authority of the State of Gujarat for Fire & Safety Audit. A copy of registration certificate will be submitted alongwith the bid/tender.
4. Rate should be quoted lumpsum as per the proforma given at Annexure-1. A list of allottes with area of plots is at Annexure-2 (clothing) and Annexure-3 (Plastic). Annexure-4 (warehousing units).
5. Bidders can carry out inspection on 20<sup>th</sup> & 21<sup>st</sup> February, 2017 from 3.00 p.m. to 5.00 p.m.
6. On placing the work order, the draft Audit Report will be submitted within three weeks and after presentation of drft audit report final report will be submitted within two weeks time.
