Shri Prabhat Jha. Vice President of the applicant company appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for setting-up a new unit in the SEZ for manufacture and export, of 1) Formal Shirts; 2) Ladies Top; and 3) Pant".

- > Proposed investment is Rs. 161.42 crore, with employment generation for 7000 person;
- Projected FOB value of exports is Rs. 424.00 crore with outgo of foreign exchange at Rs. 177.75 crore and resulting NFE of Rs. 246.25 crore for 5 year period.

Observations of the Approval Committee:-

- ➤ The requirement of land/plot area for the proposed project is very high, the Developer (GIDC) was advised to assess the actual requirement commensurate with the project, and allot the required land for the proposed project.
- The proposed project is focused for expansion, wherein exports shall be to the USA, UK.

The Committee after due diligence and deliberation approved the project, subject to standard terms and conditions, of the SEZ Rules, 2006.

11-A-02) Proposal of M/s. Kartik Sarees Pvt. Ltd., Surat, for setting up a new unit:-

Shri Vimal Fatehpuria, Director of the applicant company appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for setting-up a new unit in Gem & Jewellery - for manufacture and export, of 1) Dupatta; 2) Blouse; and 3) Scarf".

The Committee observed that the applicant had obtained LOA in May, 2007, for which they had not implemented/commenced production within the stipulated/extended validity even after over 05 (five) years of approval. Thus, the Committee was not convinced with the intentions of the applicant considering their background facts. The Committee directed the Developer to examine the fresh proposal from the applicant, and give their considerate opinion whether this application can be considered de-nova. Till the time a report is received from the Developer, the current proposal is deferred.
