The Approval Committee was given to understand that the Government of India, in the Ministry of Commerce, vide letter No. D.12/45/2009-SEZ, dated 13-09-2013, with subject "Implementation of the SEZ (Amendment) Rules, 2013 – clarifications regarding" interalia, in Para-6 of the said letter clarified/defined sectoral broad-banding provisions for categories of sectors encompass similar/related area with each broad-band sector treated as a single sector, viz. 'Textile, apparel, hosiery, fashion garments, wool and carpet'.

In view of the broader clarification of the Government of India on the aspect of sectoral broad-banding, the Approval Committee after due diligence and deliberation approved the proposal of M/s. Hi Klass Fashions, SAP-SEZ for broad-banding of the existing LOA to include new items of "Made-up textiles articles" as per request id No. 421600054374, dated 23-06-2016, subject to standard terms and conditions, of the SEZ Rules, 2006, and none of the items sought for exports is restricted items under the ITC (HS).

Authorization from the Approval Committee in terms of Section-25 of the SEZ Act, 2005, read with Rules-25 and 54 of the SEZ Rules, 2006, for penal action against M/s. Sarthak Creation Pvt.
