- The representatives of the SEZ explained the requirement of each of the services in relation to their authorized operations. For the services at above serial no. 1, they explained that most of their SEZ employees involved in authorized operations travel by air. The Developer informed that the code of the employees engaged in SEZ is tagged separately. Whenever, the project requires communication through travel, the respective employee has to travel and it is always co-related to the swan (service work order number) code vis-à-vis authorizing to travel for the respective project by air.
- The Committee after due deliberation and diligence approved the Service for inclusion in the additional list of exempted Services. It was decided by the Committee that the list of employees tagged to SEZ is submitted to the Specified Officer, and employees of the SEZ will only seek this service. The Specified Officer of the SEZ shall monitor the availment/use of the exempted service by calling for details of the respective project and ensure that it is being used only for authorized operations. (The service at serial no. 1 of the list submitted by Developer)
- The Auction services at serial no 2 is approved by the Committee exclusively for disposing off the E-waste generated in the course of the authorized operations in SEZ, and disposal of used lubricating oil taken out from the DG sets. The Committee also decided that the Specified Officer shall verify and certify the waste.
- Business Auxiliary services at serial no. 3 is approved by the Committee but limited to the services of a Commission Agent for the services to be received by the SEZ unit.
- Business Support service at serial no. 4 is approved by the Committee and deliberated that the same will be limited to the services for outsourcing of BPO/KPO services in the SEZ.

- Event Management services at serial no. 7, the Committee approved the service subject to the condition that the conducting of event should invariably within SEZ only.
- Management Consultant services at serial no. 9, is approved by the Committee.
- Rail Travel Agent services at serial no. 10, the Committee approved this service and deliberated that similar norms prescribed for the air travel agent service (serial no. 1) be adhered to.
- Restaurant Services at serial no. 12, the Committee approved this service limited to the providing of catering services provided within the SEZ for business meetings.
- Short term accommodation service in a hotel at serial no. 14, the Committee requested the unit to submit fool proof system of checks for availment of the services and the same is deferred.
- Pandal or Samiana Services at serial no. 15 and Mandap Keeper Services at serial no. 16 the Committee approved the services and deliberated that the same will be for the services provided for business events within the SEZ.
- For the services listed at serial no. 6, 8, 11, and 13 the representative of the unit informed that the same are not urgently required and did not propose for consideration.
