28-A-01) **Proposal of M/s. TCS E-Serve International Limited, Mumbai for setting up a new unit:-**

Shri Siddharth Bhogle, Chief Financial Officer of the applicant company appeared before the Committee for personal interview, and explained the proposed project in the SEZ. The proposal is for service activity and export, of IT/ITES – enabled services like “IT products, Software, IT Services, and IT enabled BPO/KPO”.

- Proposed investment is Rs. 1037.00 lakh, with employment generation for 3000 person;
- Projected FOB value of exports is Rs. 1392.27 crores with outgo of foreign exchange at Rs. 17.57 crores, and resulting NFE of Rs. 1374.70 crores;
- The Developer (TCS) has earmarked the required premises/space in the SEZ for the proposed project.

Approval Committee after due diligence and deliberation approved the project, subject to standard terms and conditions, of the SEZ Rules, 2006.
