## 3. Q V LABS PVT. LTD., BHARUCH.

The proposal is for to develop a new set up of Research and Development (R&D) Laboratory in existing premises of M/s Q V Labs Pvt. Ltd., Ankleshwar, Bharuch.

No person of the unit has appeared before the UAC for their proposal. The Committee, therefore, decided to defer the proposal.
