A) Other Proposals:-

17-A-01) Approval of list of goods required for Authorized Operations:-

Shri Girish Nanoti, GM-SCM, explained the requirement of additional items for their approved authorized operation. List of duty-free goods required by the Developer (Jubilant) for their approved Authorized Operations was taken up for consideration by the Committee. The duty-free goods are required for the following approved Authorized Operations:-

- Steam Generation Plant (coal fired boiler);
- Incinerator Plant.

The Committee after deliberation and due diligence approved the list of duty-free goods submitted vide letter dated 31-12-2013, required for the above approved Authorized Operation, subject to the standard terms and conditions of the SEZ Rules. Earlier, during the 16th meeting of the Approval Committee held on 23-09-2013 had asked the Developer (Jubilant) to furnish statement of consumption/utilization of the free goods permitted. The Developer (Jubilant) vide their letter dated 31-01-2014 have now furnished the required statements, and the same is noted by the Committee and taken on record.

17-A-02) Submission of Quarterly/Half Progress Reports by the Developer – Jubilant Infrastructure Ltd., for Chemical – SEZ, Bharuch:-



17-A-03) Request of the Developer and units in Jubilant – Chemical - SEZ, for approval of default list of taxable services, and addition of new services required in SEZ:-

The Chairman informed the Committee that the default list of 60 (sixty) services has been issued by Kandla – SEZ for all SEZs in Gujarat in order to bring uniformity. However, for any addition of new services the Approval Committee can decide on case-to case basis on merits, and was of the opinion that the current proposal needs analysis on case-to-case, with proper justification of
