Shri R. D. Singh, Head Admin & Purchase, and Shri Krishna Bhatt, Head – Admin & Compliance, of the Company explained their proposal for withdrawal of the earlier permitted change of name from M/s. L&T Ltd – Integrated Engineering Services., to M/s. L&T Technology Services Ltd., as their existing overseas customers were not accepting the new name for the present, and requested for continuation of the previous name and style of M/s. L&T Ltd – **Integrated Engineering Services**, and thus they are seeking for the withdrawal of earlier permitted name change.

The Committee after hearing their contentions and after deliberation approved the above proposal for change of name (continuation of earlier) subject to normal conditions, of the SEZ Rules, 2006, like execution of fresh Bond-cum-LUT in the new name.
