A) **Other Proposals:-**

29-A-01) **Request of M/s. Jubilant Life Sciences Ltd. (Unit-1), for Broad-banding of the LOA for inclusion of new items:-**

Shri Kashap Mapara, DGM (Production) of the applicant company appeared before the Approval Committee and explained with technical details and flow charts their request for broad-banding of LOA to include the following new products:-

The Approval Committee asked the unit to submit the approvals/permission from the Pollution Control Authority and declaration for the proposed items sought for broad-banding to the effect that the said items does not fall under the Restricted and/or Prohibited items lists. These were submitted by the unit vide their letters dated 23-01-2019, and 24-01-2019 respectively.

The Approval Committee has informed to the applicant that they shall follow all licensing procedures for the above products and they shall get all mandatory/statutory Regulatory approval from all concerned authorities, including approvals/clearances from Environment and Pollution Control Authorities.

The Approval Committee after due diligence approved the request for broad-banding of LOA, and accorded inclusion of the new finished subject to the normal terms and condition of the SEZ Rules, 2006, and further no restricted/scomet items (raw materials) can be imported for the broad-banded items.

29-A-02) **Request of M/s. Jubilant Life Sciences Ltd. (Unit-2), to use alternative raw material for manufacture and export of approved finished product.**

Shri Hiren Prajapati, Executive of the applicant company appeared before the Approval Committee and explained with technical details and flow charts their request to use alternative raw material viz. 'Gama Picoline' for manufacture and export of approved product.

The Approval Committee asked the unit to submit the approvals/permission from the Pollution Control Authority and declaration for the proposed items sought for broad-banding to

the effect that the said items does not fall under the Restricted and/or Prohibited items lists. These were submitted by the unit vide their letters dated 22-01-2019.

The Approval Committee after due diligence approved the request for use of alternative raw material for manufacture and export of approved product subject to the normal terms and condition of the SEZ Rules, 2006, and further no restricted/scomet items (raw materials) can be imported for the same.

**29-A-03) Submission of Quarterly/Half Yearly Progress Report by the Developer – Jubilant Infrastructure Ltd., for Chemicals – SEZ, Bharuch :-**

The Approval Committee noted and has taken on record the three Quarterly Progress Reports for the period from April, 2018 to September, 2018 and two Half Yearly Reports for the period from October, 2017 to September, 2018 filed by the Developer. The Approval Committee directed the Specified Officer of the SEZ to ensure that the developer shall properly account duty-free goods/materials and are properly used within the stipulated time of one (01) year as provided in the SEZ Rules, 2006, and also the Developer should ensure to have in place ERP/SAP system for all types of transaction.

Further, the Approval Committee expressed concern over the large vacant space and asked the developer to give their development plan for the notified SEZ, and the vacant space availability at present to which the developer vide their letter dated 25-01-2019 have stated that they made an investment of more than Rs. 800.00 crores on infrastructure and utilized over 50% of processing area of SEZ. Wherein there are two (02) fully functioning/exporting units, one (01) unit is under final stage of construction and shall start production by April, 2019. The developer further stated that 2 to 3 new projects in the field of pesticides, pharmaceuticals, and acetyl are in pipeline, which shall be finalized within 2 to 3 years. The Approval Committee advised to complete the said projects before the sunset clause of Income Tax, i.e. by 2020.
