27-A-01) <u>Proposal of M/s. Intas Pharmaceuticals Ltd.,unit in Zydus - Pharma-SEZ</u> for approval of additional taxable services to the .

Shri K. D. Dholakia, DGM (Indirect Taxation) and Shri Hemang Vaishnav – Asst. Manager (Indirect Taxation) of the applicant company had appeared late before the Committee and briefly explained their proposal for approval of additional taxable services as listed below, which are in addition to the already approved default list of 66 + 5 + 4 + 3 services:-

Sr. No.	Description of taxable services
01.	Business Auxiliary Service (covering reimbursement of marketing, sales promotion, product registration expenses, etc. to foreign distributor).
02.	Remuneration/commission to Directors (for service provided by Director to a company)
03.	Remittance to foreign branches to meet their routine operational expenditure including staff salaries (towards services provided by foreign branches to IPL in India, i.e. import of service by IPL.
04.	Payment of salary & reimbursement of expenses to foreign employees (towards services provided by foreign employees to IPL in India i.e. import of service by IPL).
05.	Fees paid for renewal of marketing authorizations obtained abroad.

The Unit approval Committee observed that the unit had earlier applied for approval of the four services (at sr. no. 2 to 5) of the above mentioned five services. It was also observed by the UAC that the UAC in its meeting held on 22.02.2016 had <u>already approved the service mentioned at Sr.no, 5 of the table given above</u>. Further, the Unit Approval Committee in its meeting held on 22.2.2016 <u>decided not to approve the services mentioned at Sr. No. 2 to 4 of the above table</u>. The Committee further observed that once a particular issue is decided in by the Committee earlier, it is not open to further deliberations and reconsideration especially in view of the lack of any suitable provisions in the SEZ Act, 2005 or the rules framed thereunder. Hence, the Unit approval Committee declined to deliberate again on the issue of approval of the services listed at Sr. No. 2 to 5 of the table given above.

In respect of the application of the applicant for approval of the service viz. Business Auxiliary Service (reimbursement of marketing, sales promotion, product registration expense to foreign distributor), the Approval Committee has observed that such services can be utilized for both the SEZ unit as well as the DTA unit of the applicant. Accordingly, the Approval Committee ruled that said service is approved subject to the condition that such approval is only in respect to the quantum of the service being utilized by the SEZ unit only.
